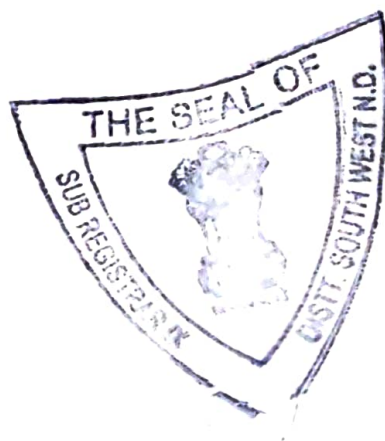

**1. Branch Establishment**

To establish a Branch Unit of **NISHAD RAJ SEWA TRUST** in the name of Chairman **Mr. Pramod, S/o Kalpnath** (Profession: Doctorate in BAMS, CCU Senior RMO, and Health Care Provider), utilizing his own property situated in **Azamgarh**. Relevant property papers are enclosed for reference.

**2. Hospital Development**

To establish and operate a **Multispecialty Hospital** with an initial capacity of **50 beds**, located at: *Mauza Bankata, Sagari, Azamgarh — Abadi 0.046 Hectares (equivalent to 461.7 square meters, fully purchased property).*

**3. Continuation of Existing Objectives**

All other objects of the Trust shall remain unchanged and continue to be pursued as per the original Trust Deed.

**4. Mr. Pramod, son of Kalpnath, served as President and dedicated his entire life to managing this NGO. After his death, his legal heirs are recognized as his wife and children, respectively. **Irrevocable Clause:- to be added**

**The Trust hereby declared shall be irrevocable.** The Settlor(s) and Trustees affirm that once this Trust is created, no part of the Trust property, nor any of its income, shall be withdrawn, transferred, or diverted for any purpose other than the objects specified in this Trust Deed. The Trust shall continue to exist perpetually for the fulfillment of its charitable and social objectives, and neither the Settlor(s) nor their legal heirs shall have any right to revoke, annul, or dissolve the Trust, except as permitted under applicable law by competent judicial authority.

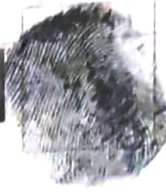

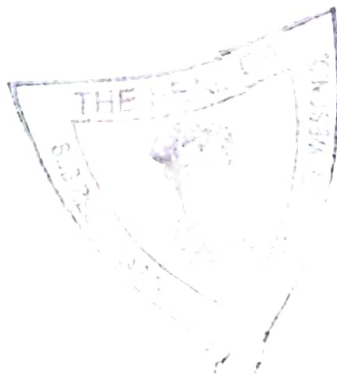

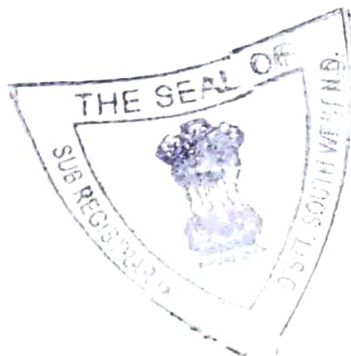
